➤ Arrange for a Second Assessment & attend hearing date.

28 days prior to the cancellation period ending go to Court closest to you and book for a "**Date of Hearing**". You will be contacted by the police for an interview.

STEP 2 ➤ Arrange for a First Assessment

(A Licence Restoration Assessment must be completed within 28 days of Date of Hearing).

STEP 3 ➤ Complete a drink driver program

STEP 4

➤ Attend Hearing Date. Present Court Order and Completion Certificate with I.D. to VicRoads.

28 days prior to ILC ending go to Court closest to you and book for ILC removal order. You will be contacted by the police for an interview.

VIC ROADS

After obtaining a **Court Order** apply to your local VicRoads office to get your licence or permit. When you are relicensed you will get the same type of licence as held previously (i.e. Learner permit, probationary or full).

PRIOR OFFENCES include a previous drink/drug driving offence, interstate offences but not drink/drug driving which occurred more than ten years ago.

DRUG TESTING Any driver in Victoria may be required to undertake a saliva test for the recent consumption of THC (Cannabis) and Methamphetamines (Speed) and Ecstasy.

INTERLOCK LICENCE CONDITION (ILC)

Breaches of the ILC can result in a fine of up to \$3200 or imprisonment for up to four months. Further, the Court may order the motor vehicle be immobolised up to 12 mths.

WRITTEN AND DRIVING TESTS

If you have not held a licence in the last **five years** you must pass a written & driving test.

DRIVING WHILE DISQUALIFIED

If you drive while disqualified the penalties are a fine of up to \$3100 or jail for up to 4 months. For unlicensed driving a fine up to \$2600 or jail for up to 3 months.

It is an offence to keep your licence or permit. The maximum penalty for keeping your licence or permit is **\$520.**
